impoverished, war-torn northeast. Parkinson was asked to start a home for needy children and destitute senior citizens that could offer hope against an uncertain future.

Parkinson established VeAhavta, a non-profit group named from the Hebrew verb meaning, "You Shall Love." The Grace Care Center - seven beaten acres in port town Trincomalee - opened in August, 2002: That same year, a cease-fire agreement was signed between the Sri Lankan government and the Liberation Tigers of Tamil Eelam. The accord provided brief hope that was soon challenged by nature; the December 26, 2004 tsunami took nearly 40,000 Sri Lankan lives and left hundreds of thousands homeless. The years following the tsunami brought escalating costs, a renewed conflict and fewer sources of funding. Grace Care Center was on the verge of closing its doors, sending the children and elders to an even more uncertain future.

In 2009, a brutal civil war spanning more than a quarter century came to an end. New friends - both in VeAhavta and Sri Lanka - continue supporting and encouraging the founding principle of the Grace Care Center. That year, administration of VeAhavta moved from California to Michigan, where volunteers provide funding and oversight for the Center and its two principal programs:

Grace Girls Home

Grace Care Center came to life when the Grace Girls Home opened on August 31, 2002. Grace Home offers a family community for about 50 girls age 6-18. The children are provided with safe shelter, food, an education, and access to medical treatment. Their eagerness to embrace these opportunities generates a spirit of peace and industry that fills the seven-acre compound.

Destitute senior citizens - elder orphans - are as much in need in the northeast as children with no family to support them. In May 2005 Mercy Home welcomed the first of an average 50 residents at Mercy Home who are provided meals, lodging and medical care.

Since Mercy Home opened, the elders formed bonds with the children, and tended to their own chores with a sense of ownership, to include cultivating modest gardens. No matter their origin, these residents have formed familial bonds with one another in the community of Grace.
